BOARDING AND RATES

DAYCARE (6AM to 7PM Same Day)

\$37 per neutered/spayed dog

\$50 per intact dog- over 6 months old

5% discount for cash payment • Payment by credit card or cash (no checks)

Overnight boarding (6am to 10am the following day. Pick up after 10 am is additional cost based on daycare rates.

\$60 1st dog, \$55 2nd dog, \$50 each dog 3rd and more - neutered/spayed

\$75 per intact dog over 6 months old

5% discount for cash payment • Payment by credit card or cash (no checks)

Reservations are required with a non-refundable deposit. Deposits are transferrable to a later date with a minimum of 2 weeks notice. Modifications to reduce the number of days on a reservation require a 2 week notice. Deposit is \$200 or the actual amount of reservation, whichever is less.

Hours:

Mon thru Sat - 6am to noon and 4 to 7 pm with appointment. No appointments from 12-4

Sunday - 6am to noon.

MISCELLANEOUS REQUESTS OR SPECIAL INSTRUCTIONS

RIGHT TO REFUSE BOARDING OR OTHER SERVICES

In its sole and unfettered discretion, with or without cause of any kind, Dog-Woods reserves the right to refuse or decline services to owner or owner's dog(s). In the event Dog-Woods is boarding owner's dog(s) at the time Dog-Woods elects to refuse or decline to provide services and so notifies owner, owner agrees to immediately arrange for the pick-up of owner's dog(s). Regardless of Dog-Woods election of refusal or declination of services, owner will be charged and agrees to pay standard boarding rates unless and until owner's dog(s) is actually removed from Dog-Woods property.

INDEMNIFICATION AND HOLD HARMLESS

Owner shall indemnify and hold harmless Dog-Woods and its owners, officers, directors, shareholders, employees, members, partners, contractors and representatives from any and all demands, claims, causes of action, lawsuits, regulatory proceedings and penalties and all other claims and liabilities whatsoever arising from Owner's boarding of its dog(s) at Dog-Woods, including, but not limited to, damage or harm caused by owner's dog(s) to other animals or personal or real property of third persons, including reimbursement of Dog-Woods' attorneys' fees and court or other costs.

OWNER RESPONSIBILITY FOR DAMAGE TO DOG-WOODS' PROPERTY

Owner is responsible for any and all damage or harm caused by owners' dog(s) to the personal or real property of Dog-Woods, and owner agrees to compensate or reimburse Dog-Woods for the estimated amount of such damage or harm at the time of pick-up of dog(s). In the event the dollar value of the damage or harm exceeds the initial estimate by Dog-Woods, owner agrees to compensate or reimburse Dog-Woods for any additional amount(s) within five (5) business days of receipt by owner of notice of any additional amount(s).

LIMITATION OF LIABILITY; DAMAGES LIMITATION

Dog-Woods' liability, if any, arising out of or relating to this agreement or the boarding and care of owner's dog(s), including, but not limited to, liability for negligence, shall not exceed the reasonable dollar value of veterinary care for or to owner's dog(s). In no event will either party be liable to the other for any consequential, indirect, special, incidental or punitive damages, regardless of the form of action, whether in an agreement, tort, strict product liability or otherwise, even if advised of the possibility of such damages and even if the damages were foreseeable.

ENTIRE AGREEMENT; AMENDMENT

This agreement contains the entire agreement and understanding of the parties hereto with respect to the boarding or care of owner's dog(s). This agreement may not be modified except in writing, signed by both the parties hereto.

ATTORNEYS' FEES AND COSTS

The parties agree that the prevailing party in any action to enforce the terms of this agreement shall be entitled to recover its costs of litigation, including attorneys' fees.
